The PADC hereby invites all interested parties to participate in the public bidding of one (1) lot of unserviceable PADC properties on an "As-Is-Where-Is" basis as indicated below:

Upon payment of a non-refundable **Bid Fee of Five Hundred Pesos Only (P/ 500.00)** to the PADC Cashier, interested buyers may get the bid documents at the Disposal Committee Secretariat, with office address at **PADC Hangar No. 2, General Aviation Area, Domestic Road, Pasay City** and telephone numbers **+639205857599/+639999998371**, from **20-30 November 2023**, between **9:00 am and 4:00 pm**. **Viewing and Inspection** for the said properties will be conducted on **20 November 2023 at 9:30 am**.

Sealed bids will be dropped at the designated drop box located inside the PADC Hangar No. 2 Board Room. **Deadline of submission is on 01 December 2023, before 9:30 am**. Late bids will not be accepted. The envelope should also include photocopy of bidder's latest Mayor's Permit and Income Tax Return, stamped "received by BIR" / eFPS. Bid shall be offered personally by the company owner or in his absence, his duly authorized representative otherwise, said bid shall be declared void. On the date of bid opening, bidders are required to bring the original copy of the foregoing documents for validation.

Opening of bids will be held on the same day (01 Dec 2023) at exactly 9:30 am at the PADC Hangar No. 2 Board Room. Winning bidder shall be announced after evaluation of all documents submitted on the same day.

Payment of full price should be made on or before **07 December 2023**.

Upon payment of the full price, the winning bidder shall be the recipient of the unserviceable properties and **required to haul the same within seven (7) working days**.

This invitation to Bid will be posted at the PADC website at padc.com.ph and conspicuous places. PADC reserves the right to reject any or all of the bids with or without cause, to annul the bidding process, to waive any defect in them and to award the bidder whose bid is the most advantageous to the government.
