## DISPOSAL OF UNSERVICEABLE/CONDEMNED NON-TECHNICAL MATERIALS

Opening and awarding of bids for the one (1) lot unserviceable PADC properties on an "As-Is-Where-Is" basis has been held last 01 December 2023, attended with seven (7) bidders. Unfortunately, it was declared as FAILED BID due to all submitted bids where lower than the floor price which is Three Hundred Thousand Pesos (P/300,000.00).

As one of the previous bidders, PADC hereby invites you to again participate in the public bidding of the one (1) lot unserviceable PADC properties on an "As-Is-Where-Is" basis as indicated below:

Sealed bid offers shall be submitted to the Disposal Committee and be dropped at the designated drop box located inside the PADC Hangar No. 2 Board Room together with the Bidder's Bond amounting to 5% of the floor price. The 5% bond shall be forfeited if the full price is not paid by the winning bidder within the prescribed period. Subject Bidder's Bond will be returned to the non-winning bidders right after the award for the winning bidder and upon presentation of the issued temporary receipts.

Submission of bids will be on July 22-25, 2024 between 8:00 AM to 4:00 PM only. Late bids will not be accepted. The envelope should also include a photocopy of the bidder's latest Mayor's Permit and Income Tax Return, stamped "received by BIR"/eFPS. The Bid shall be offered personally by the company owner or in his absence, by his duly authorized representative otherwise, said bid shall be declared void. On the date of bid opening, bidders are required to bring the original copy of the foregoing documents for validation.

Opening of bids will be held on 26 July 2024 at 9:00 AM at the PADC Hangar No. 2 Board Room. The winning bidder shall be announced after the evaluation of all documents submitted on the same day.

Payment of the full price should be made on or before 05 August 2024.

Upon payment of the full price, the winning bidder shall be the recipient of the unserviceable properties and be required to haul the same within seven (7) working days.

PADC reserves the right to reject any or all of the bids with or without cause, to annul the bidding process, to waive any defect in them and to award the bidder whose bid is the most advantageous to the government.
